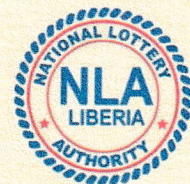

NOTICE OF DEFAULT, ADMINISTRATIVE DIRECTIVE AND DEMAND TO CEASE AND DESIST

*Sections 12, 13, 19.3 and 19.4 of the Online Gaming Licensing Service Agreement
and the National Lottery Authority Act*

Seven Blue Liberia Ltd., the Liberian special-purpose vehicle named in the Agreement
Managing Director, at the Monrovia address for service under Section 27

AND TO all officers, employees, agents, subcontractors, resellers and purported "legal representatives," including without limitation Adv. Omer Mohaban, Mr. Shahar Mor, Mohaban Mor & Co., LisCons, and every person holding out a "Liberia Online Gaming and Casino Commission."

Dear Mr. Bar-Lev:

The National Lottery Authority (the "NLA") issues this instrument as (i) a notice of default under Sections 19.3 and 19.4 of the Online Gaming Licensing Service Agreement of March 2026 (the "Agreement"); (ii) an administrative directive under the National Lottery Authority Act; and (iii) the basis of the public notices issued with it. Seven Blue Ltd, Seven Blue Liberia Ltd. and every person acting for them shall comply with Part A within forty-eight (48) hours of deemed receipt. The contractual cure period under Section 19.1.1 is separately reserved and is treated as sixty (60) days from deemed receipt. The forty-eight hour direction does not shorten or waive that period.

PART A — ADMINISTRATIVE DIRECTIVE (48 hours)

By 17:30 hours Liberia time on Saturday, 12 September 2026, you shall do all of the following.

A.1 Sole authority. Acknowledge in writing that the NLA is the only authority of the Republic of Liberia responsible for issuing gaming licenses. Seven Blue Ltd is a service provider. It is not the regulator and may not issue a license in its own name or in the name of any "Commission."

A.2 Licenses issued by Seven Blue are not NLA licenses. Every instrument, certificate, letter, portal entry or "package" issued or sold by Seven Blue Ltd, Seven Blue Liberia Ltd., LisCons, or any agent as a Liberia gaming, casino, sportsbook, lottery or prediction-market license is, from the date of this Directive, treated by the Authority as not issued by the NLA and of no force as an NLA license. Operators who paid in good faith may apply to the NLA for reissue on the terms in A.3 and A.4. Reissue is not automatic and is not an admission that the original instrument was valid.

A.3 Full listing for reissue — deliver within 48 hours. Submit to the Director General a complete schedule, in Excel and signed PDF, of:

- (a) every license you assert was issued, with license number, operator legal name, country, class (casino / sports / lottery / prediction / B2B / other), date of issue, date of expiry, domains authorized, fee invoiced, fee received, currency, receiving account, and whether any sum reached the NLA;
- (b) every application in progress, with the same fields so far as known and the present status;
- (c) every person or firm authorized or permitted by you to solicit, invoice or collect, including LegalBison, MGL Solutions, Gofaizen & Sherle, Global Law Experts, License Gaming, Tetra Consultants, Mohaban Mor & Co., and any other reseller;
- (d) the portal user list and a complete export of the licensing database and audit log.

A.4 Only the Transitory Account may receive Fees. With immediate effect, the only lawful mechanism for collecting any Fee connected with a Liberia gaming license is the USD Current Account opened in the name of the National Lottery Authority at Guaranty Trust Bank (Liberia) Limited, as confirmed by that Bank's letter dated 10 June 2026. The particulars are:

Any collection into any other account — including accounts of Seven Blue, Seven Blue Liberia Ltd., LisCons, Mohaban Mor & Co., or a reseller — is unauthorized handling of public Funds. You shall direct every Operator, applicant and agent, within the same 48 hours, that all outstanding and future Fees are to be paid only to the account above, with the Operator name and “NLA license fee” in the payment reference.

A.5 Cease misrepresentation. You and every person connected with you shall immediately cease using the name “Liberia Online Gaming and Casino Commission,” the NLA seal, the flag of Liberia, and the words “Government of Liberia,” “official regulator,” “government-backed,” or “.gov.lr” as if a contractor or law firm were the Authority. Delete or transfer to the NLA the LinkedIn page of that name. Cancel or re-label every SBC Lisbon, ICE or other slot sold as a meeting of the Commission or of the NLA unless the Director General has named the attendee in writing.

A.6 Supporting file — same deadline. Deliver the Transitory Account mandates and all statements to date; every Monthly Service Fee Statement and system extract due under Section 12.2; the June remittance trail (payer, correspondents, beneficiary account, and whether it is the GT Bank account above); and proof of Seven Blue Liberia Ltd.'s Monrovia office, staff, registration and tax clearance.



PART B — DEFAULT UNDER THE AGREEMENT

The facts in Part A, together with the matters already particularized, constitute default of material terms, including:

B.1 Section 13.1 and 13.1.1 — the Government alone promulgates the fee and owns all Fees. A published “turnkey €50,000” tariff is not the official fee.

B.2 Sections 12.1, 12.2, 12.3 and Annex C — all Fees must enter the NLA-designated Transitory Account; the Service Fee is paid only after NLA verification. The GT Bank USD account identified in A.4 is that account.

B.3 Section 5 — Seven Blue Liberia Ltd. must maintain an operational presence in Monrovia. Its acts are your acts.

B.4 Sections 8, 16 and 20 — the Solution supports NLA licensing; the vendor does not become the issuer; official marks are not a marketing asset.

B.5 Holding out a non-existent “Commission,” booking Lisbon meetings as official, and collecting through private accounts.

If these defaults are not remedied within the sixty-day period of Section 19.1.1, the Government reserves the right to issue a Termination Notice under Section 19.5; require Annex G handover; recover all off-account Fees and all sums collected above the official fee; seek injunctions in the courts of Liberia; refer the file to the Ministry of Justice and the Liberia Anti-Corruption Commission; and notify LinkedIn, GT Bank, correspondent banks and trade-show organizers. Section 19.8.1 is not waived. No Service Fee will be authorized under Section 12.3 until Part A is performed and verified.

PART C — SERVICE AND LAW

This notice is served under Section 27 on Seven Blue Ltd at the Miami address and email above and on Seven Blue Liberia Ltd. at its Monrovia address. Deemed receipt is the date of email transmission with delivery confirmation, or courier delivery, whichever first occurs. Responses shall be in writing to the Director General, copied to the Minister of Justice. Governed by the laws of the Republic of Liberia.
